



# Preston House Restoration Highlights for 2015

1. Exterior wood siding installed with square cut nails.
2. Painting of the exterior of the House to be completed by the end of August, 2015.
3. Hand forged strap hinges and thumb latches made by a local blacksmith ready to be installed on newly reproduced entry doors.
4. Hand-blown restoration glass installed in the wooden window sashes and transoms.
5. Wooden storm windows with plexiglass installed on lower windows for protection.
6. Maintenance of yard kept with monthly mowing and building debris removed from the work area this summer.
7. Wallace Bros. has quote to make repairs on and flash both chimneys in the attic.
8. Meeting planned with Washington county Building Official to discuss the beginning of the next phase which is the interior of the House.
9. Weekly meetings held throughout the year with the Committee studying architectural and building plans with the architect, job supervisor, Treasurer, Committee Chairpersons and an active Committee.
10. Local CBS Station WHJL reporter Micah Smith conducted interviews with Susan Tanner, DAR representative of Bristol.
11. The NSDAR, the Virginia Tobacco Commission support, and matching grant of \$5000, and dozens of private individuals and foundations have provided the monies for the Restoration of the Preston House.

Lectureship Program. He currently serves on the Board of Editors of Civil War History, and was a consultant to the NBC series Who Do You Think You Are? He is an accomplished writer of numerous books, articles and essays, including a regional history, Southwest Virginia's Railroad: Modernization and the Sectional Crisis, published in 1994.

# I. C. Fowler House

Scott Otis, owner of the c.1867 I.C. Fowler house, continues to make progress toward the restoration of this historic structure. Scott describes some of the work being done:

“There was significant structural damage caused by the numerous holes in the roof which allowed water into the house for years. Two load-bearing walls that supported the two bedroom floors upstairs were removed by a previous owner to park a vehicle in the house. Multiple layers of building materials from previous renovations were causing strain on the understructured original framing that was never designed to carry the weight loads that were being exerted on them. This caused bowed floors and walls, sagging roof sections and even cracked some framing members from



siding on the roof which was a significant amount of additional weight that the understructured roof was not designed to handle. The original rafters had bowed almost 3” and several were cracked from the weight load. These two damaged sections were re-framed with 2” x 6”s and new plywood sheathing. A temporary rolled roofing material was installed until the new metal roof can be installed. New wood

siding to match the original has been installed on two sides of the house and the other two sides will have new siding installed in the near future. There is still some framing to be completed inside before the wiring, plumbing and heating/cooling system can be installed.”

The I.C. Fowler house is the oldest standing house from the original Town limits of Goodson, VA. It was built by Isaac Chapman Fowler in the Greek Revival Style. Fowler owned the Bristol News, served as mayor, and was a delegate in the Virginia House of Delegates where he served as Speaker of the House. Fowler is buried in Bristol’s East Hill Cemetery.



the strain. The first floor’s floor joists have been supported in the basement with 6” x 6” beams and footers. There was 3300 lbs. of oak flooring removed from the first floor, which exposed the original wide tongue and groove pine flooring. The upstairs bedroom floors were extremely bowed, one had extensive rot and termite damage from the multiple roof leaks. These floors were removed and new framing was installed, and new pine floors to match the original ones will be installed. Two sections of the roof on the back gables had to be replaced because of rot from water leaks around both of the chimneys and roof. There were three layers of asphalt



# Tyler-Gragg House

Bristol Historical Association had the opportunity to visit the Tyler-Gragg House at 107 Tyler Dr., Bristol, TN, Wednesday, March 25, at 3:00pm, to announce the addition of the Tyler Gragg Home to the BHA Registry of Historic Places. This property has been chosen for recognition because of the importance of the original builder and owner in regional history and because of the log structure's



unusual and interesting architectural features. The property was owned by a number of well known Sullivan County citizens. In 1911 John H. Caldwell sold the property to Alonzo Jason Tyler (May 11, 1861 - December 30, 1956). Tyler was a native of Sneedville in Hancock County, Tennessee, one of seven children of Henry Tyler originally from Maine. In 1883 Tyler was admitted to the bar and very shortly thereafter was elected to the Tennessee House of Representatives. Following the annexation of the Hawaiian Islands by the United States in 1898, Tyler's party affiliation enabled him to gain from President William McKinley an appointment as a Federal judge in the islands, and he also held an appointment as State Collector of Internal Revenue at about the same time. He moved back to Tennessee in 1900 after marrying May Viola

McDermott in Rogersville, Tennessee.

In 1902 Tyler became a member of the Bench of the Second Circuit Court of Tennessee, and in 1911 they purchased the 87-acre Caldwell property where they intended to raise their children. In 1917 the Tylers commissioned Clarence Baker Kearfott, a well known Bristol architect, to draw up plans for a home. It would be a rustic, two-story log structure which family tradition says resembled a Rocky Mountain cottage that Tyler had seen and admired in Colorado.

In 1975 Robert and Roma Gragg bought the lot on which the original house was built in a neighborhood named Tyler Park in recognition of the Tyler family. Presently the property is owned by Roma Gragg and her son Lewis.

# Commissioner Bob White's Residence

Bristol Historical Association visited the historic property of the Bob White House, which is listed as the Haynes-Lowry-White House, on July 26, 2015. The house was part of the Colonel James King original holdings and it has gone through a number of notable owners, including Judge Hal Haynes. Haynes purchased the farm of over 400 acres on the courthouse steps around the turn-of-the-century, and choice parts became the Haynesfield section of Bristol. The large farm spread roughly from Weaver Pike to near Volunteer Parkway to Phlox Creek subdivision. John C. and Pauline York lived there during the depression.

Pauline was descended from the Reverend James King line and is pictured in an upstairs bedroom. Local realtor Charles J. Lowry resided there and purchased surrounding

property in the 1940s during which time he developed one of many regional housing communities.

In 2004, Bob and Michelle White purchased the home from Mr. and Mrs. Kenney Ellis who had wonderfully maintained the property since 1971. The Whites have completed much renovation to preserve the home for centuries to come.
